

# HOLY CROSS HOSPITAL

The Congregation of the Daughters of the Cross of Liège established Holy Cross Hospital in 1918 in Haslemere. The Congregation is a religious community in the Catholic Church, inspired by the Gospel story of the life-giving death of Jesus. It was founded in 1833 in Liège, Belgium by Blessed Marie Therese Haze and has since spread throughout the world. The Congregation is a registered charity in this country where it also owns and manages other Hospitals, Homes and Schools.

Holy Cross is an Independent Hospital meaning that the National Health Service does not manage it. However we have always worked closely with the NHS to provide services that are locally needed.

The Hospital was rebuilt in 1992 with facilities that are particularly designed for severely disabled people. It continues to develop special expertise in this work as well as offering general medical treatment. An extension for the Physiotherapy Centre including a hydrotherapy pool was added in 2009.

Other buildings include the Convent (the Sisters' accommodation), the Chapel and a Training Centre.

Holy Cross is not just a hospital - it is much more than that to all the people who live and work here and to the many others who support it and the values that it upholds.

***It is a Home*** – aiming to be the kind of loving home that is the basis of Christian Life. The Sisters live here and welcome all who come as patients, visitors or staff. We benefit greatly by the homely atmosphere the Sisters create. We welcome people of all faiths and of none.

***A Hospital*** - a place where professionals from different disciplines work together to provide high quality medical treatment and care. Holy Cross offers a clear sense of purpose, training opportunities and the satisfaction of working in a closely-knit team.

***And a Community*** - where all are committed to the enterprise and support each other.
